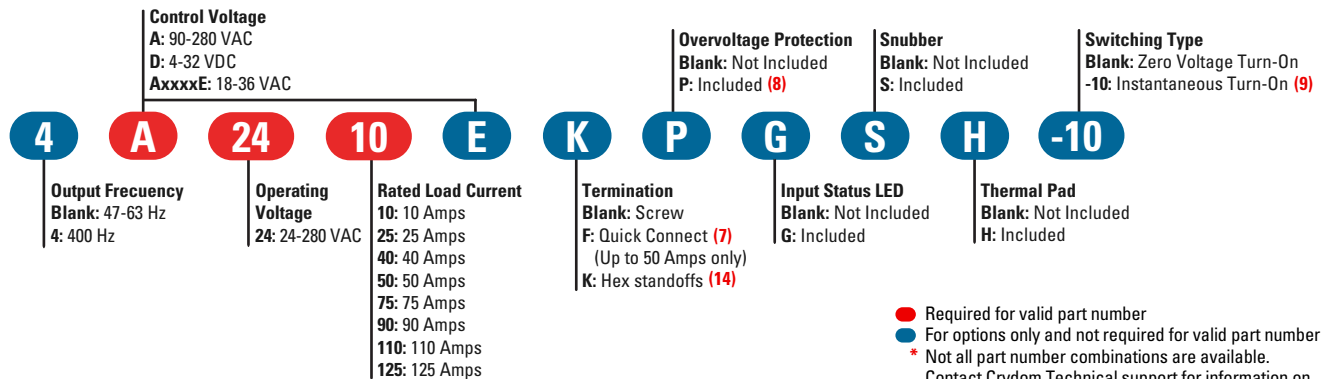

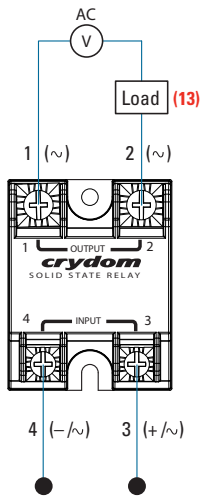

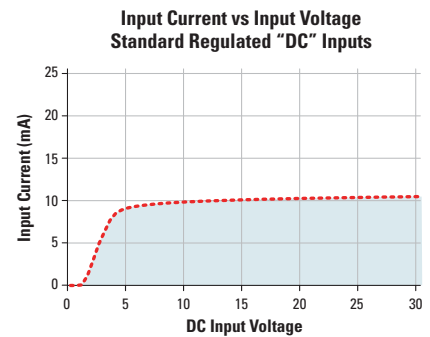

Diagram: Series 1 AC control

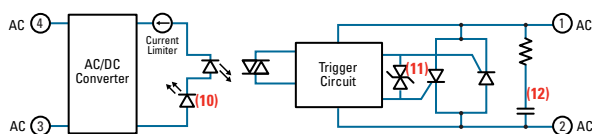
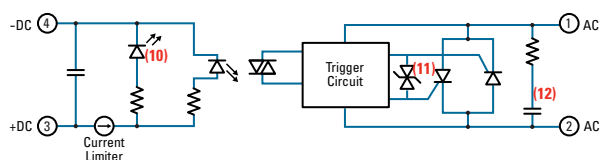


Diagram: Series 1 DC control

**SURGE CURRENT INFORMATION**



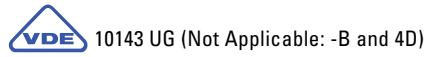




